

# Time Capsule



As part of the Centennial Clock project, on July 4, 2005, we will install a professional Time Capsule. It will be unsealed on July 4, 2039, on the 100<sup>th</sup> anniversary of the founding of the Rotary Club of San Marino.

We invite you to place one or more items in the Time Capsule. Following are suggestions to consider: letters to your children or grandchildren, birth or wedding announcements, family photographs, graduation programs, newspaper articles, directories or brochures, calendars of events, poems, advertisements, copies of historical documents, business brochures and logos, or similar items that you believe would reflect your life in San Marino in 2005. This is an opportunity to be a part of history.

This will be the first official Time Capsule in San Marino. We are excited about being a part of our community's history, and we encourage your participation. The process for submitting items is summarized on the following page.

# Time Capsule

## Process for Submitting Items

1. Select the item(s) you would like to include in the Time Capsule. Seal the item(s) in a No. 10 size envelope or a 9x12 inch manila envelope. Type or print on the envelope “***Rotary Time Capsule***”, as well as your name and address. Also if applicable, indicate any special delivery instructions upon unsealing of the Time Capsule in 2039 (such as to your child, grandchild, or a specific organization).
2. There is a suggested donation of \$10 for the No. 10 envelope and \$25 for the larger manila envelope. Checks should be payable to ***San Marino Rotary Charities*** (this is a tax-deductible contribution). Attach the check by paperclip to the envelope. Non-profit organizations need not make a donation.
3. Submit your item to Wayne Carter at a Rotary meeting (Thursdays at noon). Or you may mail your submission in a separate envelope to: Time Capsule Project, c/o Wayne Carter, 2600 Mission Street, Suite #206, San Marino, CA 91108. (Your envelope marked ***Rotary Time Capsule*** for inclusion in the Time Capsule will be inside the mailing envelope.)
4. Submissions must be received by Wayne no later than noon Thursday, June 30. This is the absolute deadline.
